In 2019, Friends of Front Street Shelter (Friends) continued its lifesaving mission to support Sacramentos municipal animal shelter, the Front Street Animal Shelter. Donor dollars help Front Street provide medical attention and behavioral modification when necessary to stray, abandoned, abused, and neglected animals. These efforts improve their chances of survival and adoption. Friends also supports regional efforts to improve the lives of animals, helping to raise the tide that lifts all boats for area shelters, rescue organizations, foster volunteers, and pet owners. By far, individual contributions through a variety of platforms constitute the major source of Friends public support. These include employer-sponsored giving platforms (sometimes with an employer match), individual contributions directly to Friends, scheduled monthly contributions, and Facebook fundraisers. Friends saw a \$136,000 increase from 2018 to 2019 in this category, approaching \$384,000 in total contributions for 2019. In May 2019, Friends continued to be the number one charity measured by individual donations in the Sacramento Regional Foundations Big Day of Giving. Donors contributed almost \$76,000 in 903 individual donations. Our Brewfest event in June raised almost \$105,000 and our Paws to Party in October took in almost \$100,000. In addition to being successful fundraisers, these events provide opportunities to educate the public about Front Streets lifesaving efforts and show donors how we use their generous donations. Friends largest annual expense is medical support, including additional help for Front Streets medical team, payments to outside veterinarians for non-routine medical care, and the purchase and maintenance of medical equipment. Friends devoted more than \$125,000 to these lifesaving needs in 2019. Our largest, one-time expenditure in 2019 was \$47,000 for a modular building to provide badly needed space for shelter staff. Friends spent almost \$39,000 to provide spaying and neutering for thousands of abandoned and feral kittens that come through Front Streets foster program every year. We invested \$21,000 in other nonprofit organizations devoted to animal welfare to help raise the tide for all. We spent almost \$20,000 in 2019 to train Front Streets staff and volunteers to provide enrichment to homeless pets and, in many cases, to help animals with behavioral issues become adoptable. Numerous additional expenditures helped to improve the welfare of animals in Front Streets care and in the community, from buying specialized food for kittens in foster care to supporting the Sacramento County District Attorneys Animal Cruelty Task Force. Friends thanks its donors for the generosity that makes all of this possible.
